NECESSARY DOCUMENTS

Employees and Domestic Service Workers:

- Application forms RV 1009/2018-DGSS and RV 1006/2018-DGSS;
- ID document and the respective simple copy – Passport, Citizen Card or other civil identification document of the country of origin;
- Copy of the tax identification document (NIF)
- Employment contract and the respective simple copy containing the following information:
 - The worker's name and address;
 - The employer's name and headquarters' address;
 - The employer's activity;
 - Activity for which the worker was hired;
 - Work place and normal working period;
 - Earnings amount and frequency of payment;
 - Date of the employment contract beginning;
 - Type of employment contract;
 - Signatures of the parties.

Self-employed workers:

- Application forms RV 1000/2019-DGSS and RV 1006/2018-DGSS;
- ID document and the respective simple copy – Passport, Citizen Card or other civil identification document of the country of origin;
- Copy of the self-employment activity beginning statement, issued by the Tax and Customs Authority
